Q#1 Can you please verify the tire sizes on item #11 and #20? I believe they should be LT235/85R16 and 9-14.5, respectively. Please advise so I can provide you with the proper pricing and product.

A#1 Item # 11 is correctly identified in the Invitation to Bid as LT235/65R16, which fits the Commission's new Ford Transit Vans.

Correct, Item # 20 tire size is 9-14.5 (not 9-4.5). The Commission hereby amends the Bid Schedule of Prices through this Addendum No. 1 to specify the correct tire size for Item #20 as 9-14.5.

Q#2 I am requesting that you approve the Roadmaster RM332 as an approved equal for the Roadmaster RM230WB. This is item #14 on solicitation#4278 in the size 385/65R22.5.

A#2 The Roadmaster RM332 is approved as equal to those specified for Item#14, and is hereby inserted alongside those identified for Item #14 in the Invitation to Bid.

Q#3 I would like to have the following products listed as approved equals for the following items listed in solicitation #4278:

- Item #14 - Goodyear G296**
- Item #15 - Goodyear Workhorse MSA**
- Item #16 - Goodyear G751 MSA**
- Item #17 - Goodyear G751 MSA**

A#3 The Goodyear G296 proposed as equal to Item #14 is rejected due to its insufficient load rating. The Goodyear Workhorse MSA is approved as equal to those specified for Item#15, and is hereby inserted alongside those identified for Item #15 in the Invitation to Bid. The Goodyear G751 MSA is approved as equal to those specified for Items #16 and #17, and is hereby inserted alongside those identified for Items #16 and #17 in the Invitation to Bid.
