**ANSWERS TO QUESTIONS RECEIVED THROUGH 1:00 PM ON JANUARY 17, 2017:**

**Q#1 Can we be provided the previously awarded rates? Considering we have bid this work for a number of years without success, it would be helpful to know who is being awarded and at what price the work is being performed. On other work we bid on, providing a tab sheet is common.**

**Q#2 What was the amount of time previously utilized to perform the services in each section last year?**

*A#2 For purposes of bid evaluation, the Commission will presume seven (7) weeks of service at the Weekly Rate and four (4) days at the Daily Rate for each Item within each Group.*

**Q#3 Is paid time allowed for travel, breaks, fueling and/or clean-up of the equipment?**

*A#3 Paid time for Monthly, Weekly and Daily Rates includes eight (8) continuous hours of operations through the Business Day with an allowance for a ten (10) minute break in the morning and afternoon and a thirty (30) minute Lunch break. Travel time, fueling time and/or clean-up is not included, and should operation subject to any rate cease in excess of fifteen (15) minutes cumulatively during any given Business Day of scheduled operations, a credit based on the Hourly Rate, prorated for the duration of time operations are not performed, shall be provided to the Commission for the actual "down time." See Page 8b and 8c.*
