ANSWERS TO QUESTIONS RECEIVED THROUGH 5:00 P.M., FEBRUARY 14, 2014:

- Q#1 I have attached information on a proposed equal to the Caterpillar 2P6000-LP lift truck. We can bid on the Elmore, Ohio Maintenance Building location.
- A#1 Based on the information provided, the Hyster H60FT forklift with the Mazda LP engine fails to meet specifications. Specifically, the Hyster fails in comparison to that specified in power train torque at rated RPM (91 ft-lbs at 1800 RPM versus 129 ft-lbs at 1600 RPM), mast free lift height (58 inches versus 86 inches), lift height to top of fork (58 inches versus 86 inches), measurement to top of forks with mast fully extended (126 inches versus 186 inches) and fork length (42 inches versus 48 inches). Therefore, the proposed fork lift is not an approved equal.
- Q#2 As part of bid 4213, there is a requirement to participate in the State of Ohio BWC Drug Free Safety Program. We do not currently participate in this program, however, we have our own policy. Please let me know if this is acceptable to submit a bid. Thanks.
- A#2 The Commission will consider a Contractor with a program that is substantially similar to the BWC program.
- Q#3 I believe that there is an error on the mast specs on your bid just FYI. The correct mast specification on a CAT 2P6000-LP with a triplex mast is 186" lift height, 85.2" overall height lowered and 37" free lift.
- A#3 Changes have been made to page 7, Specifications. See attached.
- Q#4 Here is the information on my proposed equal. Please confirm that this will be acceptable. Make: Clark; Model: C30; Lift Height: This model will meet all of the specifications of the bid as described on page 7 attached.
- A#4 Based upon the information provided, the Clark C30L with the LP engine fails to meet specifications. Specifically, the Clark 30L fails in comparison to that specified in ground clearance (6.5 inches versus 7.4 inches), maximum draw bar pull load (4,560 lbs. versus 4,742 lbs.), maximum grade-ability, loaded, (30.2% versus 40.3%), fork length (42 inches versus 48 inches), and fork carriage width (41 inches versus 39 inches). Therefore, the proposed fork lift is not an approved equal.

- 4. If the Executive Director or his designee does not approve the proposed Equal, the Procurement Manager shall notify the Bidder of the disapproval in writing, no later than twenty-four (24) hours prior to the Bid Opening, excluding Saturdays, Sundays and legal holidays, stating the reason for the disapproval, which decision shall be final. The Executive Director or his designee shall have the discretion to reject a Proposed Equal for the reason that the Bidder failed to provide sufficient information to enable the Commission to completely evaluate the Proposed Equal without delaying the scheduled Bid Opening.
- 5 No consideration shall be given to any Proposed Equal unless submitted by the Bidder to the Procurement Manager, not less than five (5) calendar days prior to the Bid Opening
- P. - **Q.** Rejection of Bid By Commission: If the lowest Bidder is not responsive or responsible, the Bidder shall be rejected and the Commission's Director of Contracts Administration shall notify the Bidder in writing by certified mail of the finding and the reasons for the finding.

A Bidder who is notified in accordance with this subparagraph may object to such Bidder's rejection by filing a written protest which must be received by the Director of Contracts Administration within five (5) days of the notification provided by the Commission

Upon receipt of a timely protest, the Director of Contracts Administration shall meet with the protesting Bidder to hear the Bidder's objections Chapter 119, ORC, shall not be applicable to such meeting.

The liquid propane (LP) powered lift truck described herein shall be new and unused, with a rated capacity of six thousand (6,000) pounds. It shall have all the standard features that are normally provided with the model being bid and include any standard options that are required to meet the specifications. The lift trucks shall be a Caterpillar 2P6000-LP, or approved equal (See page 2e, Section O for instructions on Proposed Equals), with the following options:
