ANSWERS TO QUESTIONS RECEIVED THROUGH 10:00 A.M., AUGUST 18, 2014:

Q#1 Could you please verify the contract duration as it pertains to the performance bond? It seems that it would end upon payment and acceptance of the units, with the performance bond being returned to us at that time. However there is some language which would lead me to believe the performance bond would stay in effect until the warranty on the trucks runs it's course, which in Freightliner terms would be about 5 years. I can't imagine the performance bond hanging out there for 5 years on this. Could you track that down and clarify please?

A#1 The specifications require a performance bond to remain in effect until the end of the warranty period in Group II. (See page 7c). However, the Chief Engineer shall not unreasonably withhold approval for requests to substitute a Maintenance Bond after delivery and acceptance.

Q#2 Would you consider moving the bid opening date one week out to August 29th @ 2PM EST? The bid was released on August 6th. I called the Ohio Turnpike and talked to a woman named Victoria who advised me our packet was mailed on August 8th. We did not receive our packet by USPS until August 14th. This is 6 precious work days delayed (from release date) before we even got an opportunity to look at the packet. Anything you could do to move this date out would be appreciated.
