

# OHIO TURNPIKE AND INFRASTRUCTURE COMMISSION

## Resolution Awarding Contract No. 40-16-01 for Bridge Repainting in Williams County, Ohio

WHEREAS, the Commission publicly advertised, in accordance with law, an Invitation for Bids upon a Contract for the Bridge Repainting of Fish Creek Road (C.R. 1.5) over the Ohio Turnpike at Milepost 0.9, at Ohio Turnpike over State Route 49 (ML. WB.) at Milepost 2.1, at Ohio Turnpike over State Route 49 (ML. EB.) at Milepost 2.1, and at Ohio Turnpike over Nettle Creek (ML. WB.) at Milepost 10.6, all located in Williams County, Ohio, designated as **Contract No. 40-16-01** (the "Project"); and

WHEREAS, the Commission received five bids, via Bid Express, to perform the duties prescribed for the Contractor on the Project, and the Chief Engineer's report analyzing the bids is before the Commission; and

WHEREAS, the Chief Engineer reports that **APBN, Inc.**, of **Campbell, Ohio**, submitted the lowest bid to perform the Contractor's obligations for the Project in the amount of **\$474,503.00**, which he recommends that the Commission approve as the lowest responsive and responsible bid received; and

WHEREAS, the Director of Contracts Administration advised the Commission that bids for Contract No. 40-16-01 were solicited on the basis of the same terms, conditions and specifications, that APBN, Inc. submitted a bid guarantee and performance bond with good and sufficient surety, and that the bid of APBN, Inc. conforms to the requirements of Ohio Revised Code Sections 5537.07, 9.312 and 153.54; and

WHEREAS, the Executive Director has reviewed the reports of the Chief Engineer and the Director of Contracts Administration, and concurs with the recommendation to award Contract No. 40-16-01 to APBN, Inc. as the lowest responsive and responsible bidder; and

WHEREAS, the Chief Engineer recommends the Commission assign **True Inspection Services, LLC**, of **Springfield, Ohio**, to perform the necessary construction administration and inspection services in accordance with the 2015-2016 Miscellaneous Engineering Services Agreement; and

WHEREAS, Commission action is necessary to execute the Contract in accordance with Article V, Section 1.00 of the Commission's Bylaws because the value of the bids received require expenditures for the Project under Contract No. 40-16-01 that will exceed \$150,000.00.

NOW, THEREFORE, BE IT

RESOLVED by the Ohio Turnpike and Infrastructure Commission that the bid of **APBN, Inc.**, of **Campbell, Ohio**, in the amount of **\$474,503.00** for Contract No. 40-16-01 is approved as the lowest responsive and responsible bid received and that the Executive Director is authorized to execute a Contract on the basis of said bid; and

FURTHER RESOLVED that the Commission approves the assignment of **True Inspection Services, LLC**, of **Springfield, Ohio**, to perform all necessary construction administration and inspection services in accordance with the 2015-2016 Miscellaneous Engineering Services Agreement; and

FURTHER RESOLVED that the Executive Director has the authority to approve such extra work or change orders under previously awarded said contracts as a result of an increase in the planned quantities, newly mandated requirements that did not exist at the time of original contract awards, or circumstances that would create a life, safety, or health threatening situation or would unduly delay the completion of the Project and increase its costs.
