


Middle Ridge Service Plaza Exhibit 1 to Scope of Services



### MATERIAL FOR WALL AND SEATING MILLWORK

The contractor shall construct a durable wall with a high-quality, large-format graphic suitable for a 24-hour public use environment. The choice of materials is at the discretion of the builder; however, they must ensure long-term durability, resistance to fading, scratching, and impact, as well as ease of maintenance. The graphic should be seamlessly integrated, with a high-resolution finish that maintains clarity and vibrancy under continuous exposure to artificial and natural lighting. All structural and surface treatments must be designed to withstand heavy foot traffic, incidental contact, and environmental factors such as temperature fluctuations and humidity. Respondents should detail proposed materials, construction methods, and protective finishes to ensure longevity and visual integrity.

### PREFERED OPTION IS WOOD

• Direct printed panels of natural hardwood native to Northeast Ohio (potentially Hickory)

## WALL AND SEATING MILLWORK






