Pollution Liability Insurance is required under GC Art. 12.1.3 for this Project.

Bids will be received for this Project, which includes the following:

Construction of containment for, and the removal of, existing lead paint coating; preparation and painting of all structural steel; maintenance of traffic; all other items incidental to completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **April 8, 2025, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
